

JOEY ALEXANDER 'ECLIPSE' SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. Eligibility. Joey Alexander 'Eclipse' Sweepstakes ("Sweepstakes") is open only to legal residents of the 50 United States and the District of Columbia (excluding residents of Puerto Rico and all other U.S. territories and possessions) who, at the time of Entry, are physically located in the United States and are at least thirteen (13) years old. Employees of Motema Music, LLC ("Sponsor"), its affiliates, licensees, franchisees and agents, and their immediate family members are not eligible to participate or win. 2. Entry Period. The Sweepstakes begins at 12 AM EST on April 20, 2018 and ends at 12 AM EST on May 4, 2018 ("Entry Period"). All entries must be received and recorded during the Entry Period. The Sponsor's computer is the official time-keeping device for this Sweepstakes.

3. How to Enter. You may enter the Sweepstakes (each, an "Entry") by pre-saving the album on Spotify and entering your email address. All email addresses given will be subscribed to Joey Alexander's promotional email list. Submitted Entries become the sole property of the Sponsor and will not be acknowledged or returned. Only entries from Spotify will be eligible for the prize.

4. Limitations. Proof of entering the Sweepstakes will not constitute proof of receipt by the Sponsor. If it is discovered that an entrant has registered or attempted to submit more than one Entry using multiple e-mail accounts, addresses and/or multiple identities, all of his/her Entries will be declared null and void and no prize will be awarded to such entrant. In event of a dispute regarding the identity of the person submitting an Entry, the Entry

and cannot be appealed. If the actual value of a Prize is determined to be less than the stated approximate retail value, the difference will not be awarded in cash. There are no other prizes.

Prizes are awarded "as is" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). The style, color and size of a Prize are subject to in-stock availability. Prizes will be shipped within four (4) weeks of the Prize Drawing Date.
